FICS has a significant international membership base that includes over 31 current NCSC's along with a number of educational institutions, affiliated chiropractic bodies and commercial organisations drawn from 6 regions in the world. FICS is the leading global organisation providing equitable access to sports chiropractic care, education, mentoring and research to all athletes and sports chiropractors regionally, nationally and internationally.

### Your FICS membership guarantees:

- Direct access to FICS membership as Individual Members, recognised with all benefits awarded to that category.

## Individual Membership - Process

When you apply for FICS membership, our team will first check if there is a National (NCSC) or Regional (RCSC) Commission in your country. If there is, we will share their details so you can decide whether joining that group is the best fit for you. By joining a country or regional group, you receive the full benefits of FICS global membership plus the added support of your local community.

If you choose not to join through your local NCSC or RCSC, you may still apply directly with FICS. In this case, the **fee is 125 CHF**, and we ask you to provide a short explanation of why the local or associate pathway is not suitable for you. This helps us ensure you were fully informed before making your choice.

Your application will then be reviewed by the FICS Membership Commission. No matter which path you take, FICS looks forward to welcoming you into the global sports chiropractic community.

### Other annual FICS fees for membership are:

30 CHF for NCSC members

60 CHF for RCSC members & Associate Members

125 CHF for direct individual members with FICS

As a point of difference, NCSC and RCSC members who meet eligibility criteria receive priority access to scholarships and selection for international events. If there are more applications than positions available, preference will be given to NCSC and RCSC members.
